- Age groups: 9 under, 10-15, 16-19, 20-24, 25-29, 30-34, 35-39, 40-44, 45-49, 50-54, 55-59, 60-64, 65-69, 70-74, 75-79, 80-84, 85-89, 90+.
- All 1K finishers receive a medal, shirt, and entrance to the Wild Walk to see the Nature's Nursery animals.
